Chapter 1 Introduction

1.1 Preface

Read all this information carefully before installation and operation. Follow all warnings and precautions as stated in this manual. Keep this manual available during procedures. Physicians should tell patients about all potential risks and adverse events described in this manual with respect to the operation of the system.

1.2 Indications for Use

Caution: United States federal law restricts this device to sale by or on the order of a physician.

The Hologic[®] Brevera[®] breast biopsy system with CorLumina[®] imaging technology is intended to provide breast tissue samples for diagnostic sampling of breast abnormalities. The Brevera breast biopsy system excises targeted tissue and optionally delivers in-line radiographic images of the excised tissue. The Brevera breast biopsy system is intended to provide breast tissue for histologic examination with partial or complete removal of the imaged abnormality. In instances when a patient presents with a palpable abnormality that has been classified as benign through clinical and/or radiological criteria (for example, fibroadenoma, fibrocystic lesion), the Brevera breast biopsy system may also be used to partially remove such palpable lesions. The extent of histologic abnormality cannot be reliably determined from its mammographic appearance. Therefore, the extent of removal of the imaged evidence of an abnormality does not predict the extent of removal of histological abnormality, for example, malignancy. When the sampled abnormality is not histologically benign, it is essential that the tissue margins be examined for completeness of removal using standard surgical procedure.

1.3 Contraindications

- The Brevera breast biopsy system with CorLumina imaging technology is not intended for therapeutic applications.
- The Brevera breast biopsy system with CorLumina imaging technology is contraindicated for those patients who, based on the physician's judgment, may be at increased risk or develop complications associated with core removal or biopsy. Patients receiving anticoagulant therapy or who may have bleeding disorders may be considered at increased risk of procedural complications.

1.4 Essential Performance

The essential performance of the Brevera breast biopsy system is to maintain compliance with IEC 61010-2-91:2012 to prevent exposure of the patient, operator, or other individuals to unacceptable levels of X-ray radiation.

1.5 System Capabilities

The Hologic Brevera breast biopsy system with CorLumina imaging technology is a vacuum-assisted biopsy device which is used to remove breast tissue in a minimally invasive manner using stereotactic or tomosynthesis imaging. The system is designed for biopsy and for specimen radiographic image acquisition and display only. The system is NOT intended to be used outside the standards, specifications, and limitations outlined in these instructions for use.

The Brevera biopsy needle is single-use and is disposable. The user connects the biopsy needle to a reusable device driver and connects the biopsy device components to the console. The biopsy needle primarily consists of a hollow needle with a side aperture and a sharpened inner cannula that, when connected to the Brevera breast biopsy system, rotates and extends across the aperture to acquire targeted tissue. The Brevera device driver contains mechanical and electrical components that drive needle rotation and advancement. During the biopsy process, vacuum created inside the biopsy device pulls tissue into the aperture. The cannula translates and rotates to cut the tissue. The tissue sample is then aspirated through a tubing line to a tissue filter. Saline is supplied through the biopsy device to lavage the cavity and deliver tissue to the tissue filter.

When the Brevera biopsy needle is connected to the Brevera device driver, the combination is referred to as the Brevera breast biopsy device.

An introducer system, specifically designed for use with the Brevera breast biopsy system, is packaged with the biopsy needle. This introducer maintains access to the targeted area of interest and allows for deployment of a biopsy site marker. The introducer is used to control the variable aperture function of the device. The introducer also prohibits the user from administering medication through the Y-site in the tubing while the device is in the armed (pre-fire) position.

The Brevera breast biopsy system with CorLumina imaging technology acquires and displays the radiographic images of core specimens contained in the tissue filter. A tissue filter, specifically designed for use with the Brevera breast biopsy system, is provided with the biopsy needle. The Brevera breast biopsy system with CorLumina imaging technology also has the capability to display images as well as to transfer these images to external devices. The images acquired with this system are intended to confirm removal of tissue from a suspected lesion or pathology. The system is not intended for diagnostic purposes.

Radiology technologists, surgical personnel, surgeons, radiologists, and pathologists can use the specimen radiography equipment in the Brevera breast biopsy system with CorLumina imaging technology.

Hologic recommends that users receive training in basic ionizing radiation safety before using the system.

Chapter 2 General Information

2.1 System Overview

The Brevera breast biopsy system with CorLumina imaging technology has system components for vacuum-assisted breast tissue biopsy and system components for x-ray generation and image acquisition. The user interface for data entry, patient selection, and image acquisition and review is on the Imaging display. The user interfaces for controlling the modes of the biopsy device are buttons on the Technologist display and also on the remote control. The user interface for arming and firing the biopsy device is on the remote control. The user adjusts the rotation of the aperture on the biopsy device with the aperture knob on the disposable biopsy needle. The user adjusts the dimension of the aperture on the biopsy device using the introducer.




Figure Legend

2.3 Warnings and Precautions



WARNING!

The Brevera breast biopsy system must be installed and put into service according to the guidance provided in these instructions to ensure its electromagnetic compatibility. Refer to the electromagnetic emissions and immunity tables.



WARNING!

Portable and mobile RF communications equipment can affect the Brevera breast biopsy system. Do not use portable RF communications equipment any closer than 30 cm (12 inches) to any part of the Brevera system, including cables.



WARNING!

The Brevera breast biopsy system console is designed to use the power cord provided. Do not use a different power cord. Using a different power cord can create an electrical and fire hazard. DO NOT remove the ground wire or ground prong from any power plug. DO NOT use an extension cord with this equipment. An adapter may be necessary depending on the outlet used.



WARNING!

Make sure that the power cord for the Brevera breast biopsy system console is in good condition. A damaged power cord can be an electrical shock hazard. When disconnecting the console from power, always grasp the plug at the insertion point and pull lightly. NEVER pull on the cord to unplug the unit.

There is no guarantee that interference will not occur in a particular installation. If the console does cause harmful interference to other devices, which can be determined by turning the console off and on, the user is encouraged to try to correct the interference by one or more of the following measures: reorient or relocate the receiving device; increase the separation between the equipment; connect the console to an outlet on a circuit different from that to which the other device is connected; or consult Technical Support.



Caution:

To prevent internal heat buildup, allow sufficient air circulation around the console. Do not place the console within .3 meters (1 foot) of any obstructive surface.



Caution:

Use and store the console in a location away from heat sources such as radiators or air ducts, direct sunlight, excessive dust, mechanical vibration, or shock.



Caution:

Do not operate the equipment at altitudes higher than 3,000 meters (9,842 feet). Do not store or operate the equipment in conditions outside of the stated equipment storage, transport, and operating environmental conditions.

Allow the console to acclimate for 24 hours before use after removal from storage.



Caution:

Risk of data loss. Do not put any magnetic media near or on devices that create any magnetic fields.



Caution:

To prevent possible damage to the system, follow the recommended procedure to turn off the equipment.



Caution:

Never use strong solvents or abrasive cleansers to clean the console since these will damage the console casing. Clean the console after the power cord is disconnected from the power outlet.



Caution:

Use the least possible amount of cleaning fluids. The fluids must not flow or run.



Caution:

To prevent damage to the electronic components, do not use disinfectant sprays on the system.



Caution:

The weight and mobility of this system require the following precautions:

- Be careful when you move the system on uneven or sloped surfaces.
- Make sure that the wheels are locked when the system is stationary.

• Before you move the system, make sure that the cables are stored in a safe position and that the display screens are pushed down to their lowest heights. Make sure that all four casters are unlocked.

• Do not make quick stops. Do not move with excessive force.



Caution:

The system is a laboratory device and not a normal computer. Do not make changes to the hardware or software that are not authorized. Install this device behind a firewall for network security. The computer virus protection or network security for this laboratory device is not provided (for example, a computer firewall). The network security and anti-virus provisions are the responsibility of the user.



Caution:

If you are a Hologic customer in the United States, contact Hologic if you cannot correct a problem using these instructions for use. Outside of the United States, contact your distributor or local Hologic representative with questions, comments, or technical service issues.

2.4 Interlocks

The x-ray generation stops automatically and a system message or alert appears when there is an interruption of an x-ray exposure. (Examples of x-ray interruptions include: the mAs timer or maximum exposure timer times out, the tissue filter drawer is opened, or the key switch is turned to the locked position.) To make another exposure:

- 1. Select the **OK** button in the system message dialog box.
- 2. Select the status icon (shaped like the Brevera breast biopsy console) in the taskbar at the bottom of the Imaging display screen.
- 3. Complete any action (such as "close the drawer") that shows in the system message area of the Imaging display screen.
- 4. Select the Clear All Faults option.

2.5 Compliance




Figure 2: Label Locations




Figure 3: System Components (Front, Right)




Figure 4: System Components (Back, Left)

3.1.1 Imaging Cabinet Components

The Brevera console houses a cabinet where the biopsy cores are collected and imaged. The cores are collected in a disposable tissue filter that is placed in the drawer of the imaging cabinet. The imaging cabinet includes a panel that gives status information about the x-ray system.




Figure 5: Imaging Cabinet Components




Figure 6: Suction Canister Components

3.1.3 **Biopsy Device Components**

The Brevera breast biopsy device consists of a sterile, disposable biopsy needle that locks into the non-sterile, Brevera reusable device driver. The biopsy needle includes a tissue filter assembly to collect the biopsy cores for imaging.

Device Driver Components

The device driver is the electromechanical component of the biopsy device. When connected to the biopsy needle, the device driver rotates and advances the cutting cannula. The device driver also arms and fires the biopsy needle.




Figure 7: Device Driver Components

Do not touch the metal parts of the device driver and the patient simultaneously.




Figure 8: Metal Parts of the Device Driver

Store the device driver on the top of the console in the device driver holder. Wrap the device driver cord (with the remote control) clockwise around the corresponding cord management plate on the back of the console.

Biopsy Needle Components

The biopsy needle includes the disposable needle itself and the tubing for the vacuum and saline lines. The biopsy needle also includes a tissue filter assembly to collect the biopsy cores for imaging. The biopsy needle is packaged with the tissue filter assembly and the introducer.





Figure 9: Biopsy Needle Components




Figure 10: Biopsy Needle Components - Detailed

Tissue Filter Components

The tissue filter is a twelve-chambered container where the biopsy cores are collected for imaging. During the biopsy process, the tissue samples are aspirated through the biopsy needle tubing to the in-line tissue filter. A tissue filter cap is provided to cover and seal the tissue filter for storage in formalin.




Figure 11: Tissue Filter Components




Figure 12: System Connections



WARNING!

The Brevera breast biopsy system console is designed to use the power cord provided. Do not use a different power cord. Using a different power cord can create an electrical and fire hazard. DO NOT remove the ground wire or ground prong from any power plug. DO NOT use an extension cord with this equipment. An adapter may be necessary depending on the outlet used.



WARNING!

Make sure that the power cord for the Brevera breast biopsy system console is in good condition. A damaged power cord can be an electrical shock hazard. When disconnecting the console from power, always grasp the plug at the insertion point and pull lightly. NEVER pull on the cord to unplug the unit.



Warning:

The use of any cables or accessories other than those specified in these instructions can result in increased emissions or decreased immunity of the Brevera breast biopsy system.



Caution:

Grounding reliability can only be achieved when this equipment is connected to a receptacle marked "hospital grade". Check grounding continuity regularly.

3.2.1 Power and Network Connections

- 1. Put the Brevera breast biopsy system in a location where you can easily access power connections and network connections.
- 2. Connect the system AC power cord to the electrical outlet.



Position the console so that you can easily access the AC power cord connection to the electrical outlet.

3. (Optional) Connect the network cable to the Ethernet connector.

3.2.2 Footswitch Connection



Warning:

Position the footswitch and power cords to prevent accidental tripping.

Warning: Position the footswitch to prevent accidental operation by a patient or wheelchair.

The footswitch is initially installed by a Service Engineer. If the footswitch is disconnected from the console, insert the footswitch cord into the footswitch receptacle (on the back of the console). The red dots align at the top when attached correctly.

3.2.3 Device Driver and Remote Control Connections

The device driver cord has an in-line remote control. The device driver cord attaches to the device driver receptacle on the left side of the saline tubing management plate, near the saline pinch valve. The red dots will align at the top when attached correctly.



Warning:

Do not place fingers on the metal parts of the device driver. These parts can move during system use.




Figure 13: Device Driver Connection

3.2.4 Suction Canister Connections

The system will generate vacuum when the proper modes are selected. The vacuum connections require a suction canister. The suction canister connects to the suction tubing from the tissue filter and to the tubing of the vacuum line assembly. The vacuum line assembly includes a hydrophobic filter and is required to prevent backflow into the console.




Figure 14: Suction Canister Connections

3.2.5 Biopsy Needle Connections



Warning:

Before use, inspect the protective packaging and the needle to confirm that neither has been damaged during shipment. If the packaging or the needle appear to be compromised, do not use the needle.



Warning:

Do not connect the biopsy needle until the system is powered on.



Warning:

To maintain sterility, leave the protective sheath on the tip of the biopsy needle.

The biopsy needle is packaged with the suction and saline tubing, the tissue filter, and the introducer. The biopsy needle is already connected to the suction and saline lines. The suction tubing includes an in-line tissue filter assembly. The tissue filter comes preassembled and is placed in the tissue filter drawer. Refer to <u>Tissue Filter Connections</u> on page 36 for more information on connecting the tissue filter.

The biopsy needle is powered by the device driver. The biopsy needle is connected to the device driver by carefully lining up and moving the needle down over the driver until it engages. The needle is then slid forward until it locks into position. The connected combination of the biopsy needle and the device driver is referred to as the biopsy device. For complete instructions on connecting the biopsy needle to the device driver, refer to <u>Connect the Device Driver and the Biopsy Supplies</u> on page 69.




Figure 15: Biopsy Needle and Device Driver Connection



Warning:

Make sure that the biopsy needle is fully latched onto the device driver.

Tissue Filter Connections

The biopsy core travels through the suction tubing to the tissue filter in the tissue filter drawer when the proper modes are selected.



Each Brevera disposable biopsy needle package includes a tissue filter cap. Save the tissue filter cap until the biopsy acquisition is complete. The tissue filter cap covers the tissue filter when the biopsy cores are placed in formalin.




Figure 16: Tissue Filter Connections in the Tissue Filter Drawer

- 4. Guide for the suction tubing (clear tubing with a blue connector end) to the suction canister




Figure 17: Tissue Filter Tubing Connection to the Suction Canister





Figure 18: Imaging Panel Controls and Indicators

3.4 How to Lock and Unlock a Caster

- To lock a caster, step on the locking lever on the wheel until the lever locks.
- To unlock a caster, lift the locking lever on the wheel to the UP position.

3.5 How to Move the Console

Note

The power cord and footswitch cord wrap on the right side of the console to provide safe storage of the cords during console movement.



Note

The device driver cord wraps on the left side of the console to provide safe storage of the cord during console movement.

- 1. Wrap all cords on the corresponding cord management plates.
- 2. Make sure all components and cables are in a safe position on the console.
- 3. Depress the Imaging display height adjust release pedal and push the Imaging display to slide down to the lowest height. Release the pedal to lock the height.
- 4. Rotate both the Imaging display and the Technologist display so that they are as compact as possible.
- 5. Unlock all the caster locks.
- 6. Move the console by pushing the console handle.
- 7. Make sure to lock the casters when the console is at the correct location.

3.6 How to Start the System



Warning:

Do not place fingers on the metal parts of the device driver. These parts can move when the system powers on.

Note

The console beeps three times before resetting the position of the metal parts of the device driver.

- 1. Lock the console casters.
- 2. Connect the system to power and the network.
- 3. Press the **Power** button on the side of the console.
- 4. When the *Startup* screen appears on the Imaging display, select the **Log In** button.




Figure 20: Startup Screen

- 2. Enter your password.
- 3. Select the Log In button.

To change the system language or other preferences, access the Admin screen.

3.7 How to Shut Down the System

- 1. From the *Procedure* screen, select the **Close Patient** button.
- 2. From the *Select Patient* screen, select the **Log Out** button.
- 3. Select the **Shutdown** button on the Imaging display or press the console Power button.
 - If the system is not ready for shutdown, a prompt displays the option to continue or cancel the system shutdown. Select the **Check** button on the Technologist display to stop all pending jobs and continue shutdown. Select the **X** button on the Technologist display to keep the system running and finish pending jobs.






Figure 24: Add Patient Screens




Figure 25: The Edit Patient Information Screens

The Filter Criteria and Columns Tabs in the Patient Filter Screen

The **Filter Criteria** tab allows you to change the filtering options for the patient list. When you select or deselect an option, the change shows in the results area of the screen.



A Manager can save these new filters to the selected tab in the *Select Patient* screen (refer to <u>Other Functions of the Filter Criteria</u> on page 49).

The **Columns** tab allows you to add more search options (for example, Age, Gender, Date of Birth) to the filtered list. The options display as columns in the results area. To add more columns to a filtered list, select the **Columns** tab, and then select the options.

The default fields are as follows: Patient Name, Patient ID, Accession Number, Requested Procedure ID, Scheduled Procedure Date. The scheduled procedure is displayed and the patient is added to the local database.




Figure 27: An Example Procedure Screen

4.3.4 How to Access the Image Enhancement Tools

Select the **Tools** button on the *Procedure* screen to access the tools bar and image enhancement features. Refer to <u>Image Enhancement Tools</u> on page 92 for more information.

4.3.5 How to Access the Filter Info

Select the **Filter Info** button to access filter information such as laterality, accession number, procedure information, and filter comments. Refer to <u>*The Filter Info and*</u> <u>*Comments Screen*</u> on page 92 for more information.

4.3.6 How to Access the Reimage Feature

Select the **Reimage** button to acquire a new image of a specimen already in the tissue filter chambers. Refer to *How to Reimage* on page 94 for more information.

4.3.7 How to Close a Patient

Select the **Close Patient** button. Select **Yes** to the confirmation prompt. The system returns to the *Select Patient* screen and automatically saves to the configured output devices any images that were not sent previously.

4.4 How to Use the Output Set

The images are sent automatically to the output devices in the selected Output Set when a patient is closed.

4.4.1 How to Select an Output Set

Select an output device set like PACS, CAD devices, and printers from the Output Set drop-down menu in the *Procedure* screen.



Note

Images are not sent if an Output Set is not selected.

4.4.2 How to Add or Edit an Output Set



Note

The configuration of Output Sets occurs during installation, but you can edit existing groups or add new groups.

To add a new Output Set:

- 1. Access the *Admin* screen.
- 2. Select the Manage Output Groups button.
- 3. Select the **New** button, type the information, then select the output device(s).
- 4. Select the Add button. When the Update Successful message appears, select OK.
- 5. You can select any group to set as the default by selecting the **Set As Default** button.

To edit an Output Set:

- 1. Access the *Admin* screen.
- 2. Select the Manage Output Groups button.
- 3. Select the group to be edited.
- 4. Select the **Edit** button, then make the changes.
- 5. Select the **Save** button. When the Update Successful message appears, select **OK**.

4.4.3 How to Use the On-Demand Outputs

The On-Demand Outputs are: Archive, Export, or Print. You can manually Archive, Export, or Print an image until the patient is closed.

When you select an On-Demand Output button, you have the option to send the image to any of the configured Outputs.

How to Export

The export function sends data to a mapped drive such as a local hard drive, a USB device connected to the console, or a network drive.

- 1. Select the **Archive/Export** button. The images from the current procedure appear in the main window.
 - The archive function sends data to a PACS device.
- 2. Touch one or more images to select the images to archive or export. Touch again to deselect an image. Use the **Select All** button to select all of the images for the current procedure. Use the **Select Tagged** button to select only the images marked with a green check mark.




Figure 29: Example, Two Images Selected for Archive/Export

- 4. Select the Print preview on the left side of the screen to put the selected image on the film.
- 5. To put other images on the film, repeat steps 3 and 4.
- 6. To print a different film format of the same images, select the **New Film** button and repeat steps 2 to 4.
- 7. Select the **Print** button to print your films.

4.4.4 How to Do the Gain Calibration

Do the Gain Calibration monthly and when artifacts are seen.



Note

When the system shows the Gain Calibration message, do the calibration before you proceed with using the system. If you do the Gain Calibration at a different time, access the procedure through the *Admin* screen.

- 1. Select **Yes** to do the calibration now. If you select **No**, the system shows the *Select Patient* screen.
- 2. If you select to do the calibration now, you are prompted to select an Automatic Gain Calibration mode. Select **Yes** for Automatic Gain Calibration or **No** for Manual Gain Calibration.
- 3. Make sure that there are no items in the tissue filter drawer and that the surface of the x-ray imaging area is clean. Close the tissue filter drawer. Select **OK** to begin.
- 4. For Automatic Gain Calibration, the system takes four images.



Note

In the event that the system is unable to complete an Automatic Gain Calibration, the user can continue with Manual Gain Calibration. To continue calibration, use the manual x-ray function until four images are acquired. The system can complete Gain Calibration using the combination of automatically acquired and manually acquired images.

5. After four images have been acquired, select the **Complete Calibration** button to start the calibration. When the Gain Calibration is finished, a message about successful completion appears. Select **OK** to return to the previous screen.

For Manual Gain Calibration:

- 1. Make sure that there are no items in the tissue filter drawer and that the surface of the x-ray imaging area is clean. Close the tissue filter drawer. Press **OK** to begin.
- 2. Press the **X-ray** button.
- 3. Wait for the system to return to the Ready state.
- 4. Repeat steps 2 and 3 until you acquire four images.
- 5. After four images have been acquired, select the **Complete Calibration** button to start the calibration. When the Gain Calibration is finished, a message about successful completion appears. Select **OK** to return to the previous screen.

Chapter 5 User Interface - Technologist Display

The system has five biopsy system modes controlled by the Technologist display: Standby, Test, Biopsy, Lavage, and Aspirate.

5.1 Technologist Display Screens and Modes

When the Brevera breast biopsy system powers on, it requires setup and a test cycle. Setup and testing are completed by following the prompts on the Technologist display.

Setup

After powering on the system, the *Setup* screen appears on the Technologist display. The system will automatically detect and confirm the connections for the device driver, biopsy needle, tissue filter assembly, and x-ray system. Follow the prompts to manually finish setup. The X-ray system will not show a Ready status until patient information is entered on the Imaging display.




Figure 32: Setup Screen

Test

After setup is successful, the system requires testing. The device driver, biopsy needle, and tissue filter must be connected and installed to run Test mode. It is not necessary for the X-ray system to be ready to run Test mode. When the system is in Test mode, it tests the vacuum, prompts the user to confirm saline flow at the tip of the needle, then tests the cutting cycle. The system cannot use the x-ray function in Test mode.

When the system is ready for testing, the green light above the **Test** button flashes. Press the **Test** button to begin the testing procedure. Follow the prompts to complete testing. The Arm and Fire functions can also be tested. After testing is complete, the system can be put into Standby mode.




Figure 33: Test Screen



Warning:

Keep fingers and hands away from the biopsy device during Arm and Fire testing.

Leave the protective sheath on the biopsy device tip during Arm and Fire testing.




Figure 34: Test Screen - Arm and Fire

Standby

When the system is in Standby mode, the vacuum is off and, if a biopsy device is connected, the aperture on the needle is closed. The system cannot arm or fire the biopsy needle when it is in Standby mode. The user must change the console from Standby mode to Biopsy mode to use the biopsy device and x-ray function.




Figure 35: Standby Screen

Biopsy

When the system is in Biopsy mode, depressing the footswitch activates the vacuum and operation of the biopsy device. In Biopsy mode, the biopsy device can be armed and fired with the remote control. As part of the normal cutting cycle, the system performs a brief aspiration with each core acquisition. Removing pressure from the footswitch inactivates or stops the device *after* completion of the current cycle.




Figure 36: Biopsy Screen

Lavage

When the system is in Lavage mode, the vacuum system is activated and will pull saline through the system. The aperture on the needle is open during Lavage mode. Depressing the footswitch does not control the flow of saline in Lavage mode.




Figure 37: Lavage Screen

Aspirate

When the system is in Aspirate mode, the vacuum system is continuously on and the aperture on the needle is open. Aspirate mode allows for continuous vacuum to aspirate the biopsy cavity. Saline does not flow in Aspirate mode. Depressing the footswitch does not control the flow of air or the vacuum in Aspirate mode.




Figure 38: Aspirate Screen

Chapter 6 Imaging System Modes

6.1 X-ray Mode

X-ray mode is the default mode of the Imaging system. To use the X-ray mode, start up the system and log in. Make sure the key switch on the imaging panel is in the unlocked position.

6.2 No X-ray Mode

The system also has a No X-ray mode that allows the user to perform a biopsy without taking any images. To enter No X-ray mode, select the **No X-ray** button on the *Startup* screen on the Imaging display.

When the system is in No X-ray mode, the tissue filter moves one position after each biopsy cycle and the number of biopsy cycles completed is shown on the Technologist display (same as in X-ray mode). Standby, Test, Biopsy, Lavage, and Aspirate modes operate in normal fashion. The user interface screens on the Imaging display are absent. In place of the X-ray image, a real-time video of the tissue filter is displayed.




Figure 39: No X-ray Screen

6.3 Single Chamber Mode

The system has a specialized mode that enables the user to perform a biopsy without taking any images when the Imaging system cannot detect or index the tissue filter. The Single Chamber tissue filter does not move or change position during the biopsy acquisition cycle. The number of biopsy cycles/acquisitions completed is displayed on the Technologist display (same as the other system modes). Standby, Test, Biopsy, Lavage, and Aspirate modes operate in normal fashion.

To enter Single Chamber mode, select the System Status icon on the taskbar, then select **Single Chamber** from the menu.

In Single Chamber mode, only a Single Chamber tissue filter can be used. The system prompts the user to install the Single Chamber tissue filter.



WARNING!

Do not proceed with the biopsy until the single chamber tissue filter is installed. Failure to install the single chamber tissue filter can result in lost cores.



Warning:

Using a twelve chamber tissue filter during single chamber mode causes all cores to collect in one chamber and can cause system damage.






Figure 42: Single Chamber Tissue Filter

The Imaging display does not show the usual user interface screens. In place of the x-ray image, the Imaging display shows a real-time video of the tissue filter.




Figure 43: Single Chamber Video

Chapter 7 Biopsy

7.1 Set Up the System

- 1. Move the console into position and lock the casters.
- 2. Make sure the footswitch is connected.
- 3. Connect the console to power.
- 4. Connect the network cable to the Ethernet port (optional).
- 5. Power on the console.



Warning:

Do not place fingers on the metal parts of the device driver. These parts can move when the system powers on.

7.2 Connect the Device Driver and the Biopsy Supplies

Suction Canister

- 1. Attach the canister lid to the canister base.
- 2. Secure the large opening cap onto the large opening.
- 3. Place the suction canister in the canister holder on the console with the patient port pointing to the right.
- 4. Plug the vacuum line assembly into the top port labeled "VACUUM" on the suction canister lid.
- 5. Make sure that all connections are secure and sealed to avoid vacuum leaks.

Device Driver



Warning:

Do not place fingers on the metal parts of the device driver. These parts can move before a biopsy needle is installed.

- 1. Slide the device driver onto the device driver holder on the console until it clicks.
- 2. Confirm that the device driver cord is connected to the receptacle. The receptacle is on the left side of the console, near the saline pinch valve.

Note

The console beeps three times before resetting the position of the metal parts of the device driver.

- 3. Wait for the device driver to home before attaching the biopsy needle.
- 4. Press the **Check** button on the Technologist display if the device driver needs to be rehomed.

Biopsy Needle and Tubing



Warning:

Before use, inspect the protective packaging and needle to verify that neither has been damaged during shipment. If it appears that the packaging or needle has been compromised, do not use the needle.



Warning:

Do not connect the biopsy needle until the system is powered on and the device driver is homed and ready.

- 1. Place the sealed packaging for the biopsy needle on the console tray.
- 2. Peel open the sterile packaging of the biopsy needle.
- 3. Remove the biopsy needle from the tray, leaving the tubing and the tissue filter in the tray. Make sure the biopsy needle gears are fully forward, toward the needle tip.



Warning:

To maintain sterility, leave the protective sheath on the tip of the biopsy needle.

4. Hold the biopsy needle in one hand, with the gears facing down and the sheathed needle tip facing to the right. Line up the tab on the biopsy needle with the notch in the device driver.



Warning:

Do not place fingers on the metal parts of the device driver. These parts can move before a biopsy needle is installed.

5. Carefully move the biopsy needle straight down, aligning the back of the tab with the back of the notch, until the needle engages with the driver. Do not drag the biopsy needle across the device driver.




Figure 44: Connect the Biopsy Needle to the Device Driver



Warning:

Do not place fingers on the device driver when system power is on. Parts can move unexpectedly.

6. Slide the biopsy needle forward (to the right) until it locks into position with a click.

Warning:

Make sure that the biopsy needle is fully latched onto the device driver.

- 7. Get a saline bag and remove the protective cap. (A 250 cc saline bag is recommended.)
- 8. Remove the saline tubing from the biopsy needle packaging.
- 9. Insert the spike into the saline bag.



WARNING!

Make sure you use an aseptic technique when spiking the saline bag to prevent contamination.

- 10. Place the saline bag on the saline bag hook on the left side of the console.
- 11. Route the saline tubing from the spike through the saline tubing notch, counterclockwise around the saline tubing management plate, and through the saline tubing conduit.
- 12. Insert the larger diameter section of the saline tubing into the saline pinch valve. Make sure the saline tubing is fully seated.




Figure 45: Placement of the Saline Tubing in the Saline Pinch Valve

13. Insert the vacuum tubing into the guide at the top of the saline tubing management plate.

Tissue Filter

- 1. Pull open the tissue filter drawer.
- 2. Remove the tissue filter assembly from the biopsy needle packaging.
- 3. Confirm that the tissue filter housing is securely in place. (If needed, refer to <u>*Tissue Filter Components*</u> on page 30 for component assembly instructions.)
- 4. Put the tissue filter assembly in the center of the tissue filter drawer. Align the notch on the left-hand side of the tissue filter with the tab in the drawer. Seat the tissue filter on the four locator pins. Keep the tissue filter housing cover on the tissue filter as shown in the following figure.




Figure 46: Seat the Tissue Filter in the Tissue Filter Drawer



Note

Each Brevera disposable biopsy needle includes a tissue filter cap. Save the tissue filter cap until the biopsy acquisition is complete. The tissue filter cap covers the tissue filter when the biopsy cores are placed in formalin.

- 5. Feed the gray tubing through the guide on the left side and feed the clear tubing through the guide on the right side of the drawer so that the drawer is able to close.
- 6. Push the blue connector on the end of the clear vacuum line onto the horizontal side port marked "PATIENT" on the suction canister lid.




Figure 47: Connect the Tissue Filter Tubing to the Suction Canister

7. Close the tissue filter drawer.

7.3 **Pre-Procedure System Check**

- 1. With the console in the desired location and powered on, the default mode is Standby. In Standby mode, the green LED indicator flashes above the **Test** button.
- 2. Assemble the Brevera breast biopsy device. Refer to <u>*Connect the Device Driver and the Biopsy Supplies*</u> on page 69 for information on assembling the biopsy device.



Warning:

Leave the protective sheath on the biopsy device tip to maintain sterility.

- Confirm that the suction canister and tissue filter are assembled and placed in the console. Confirm that the vacuum line assembly and tubing are correctly connected. See <u>Components, Controls, and Indicators</u> on page 21 for more information on individual component assembly and connections.
- 4. Confirm that the silicone section of the saline tubing line is properly positioned in the saline pinch valve.
- 5. Confirm that the saline spike is correctly positioned in the saline bag and that the saline bag is hanging from the saline hook. Confirm that the saline flows freely from the bag.
- 6. Press the **Test** button on the Technologist display to switch the mode to Test mode. Follow the prompts on the Technologist display. Test mode will prime the system and generate vacuum.
- 7. Visually verify the flow of saline into the aperture of the biopsy device. Press the **Check** button on the Technologist display to confirm the saline flow.



WARNING!

Make sure the saline flows into the biopsy device to prevent lost cores and patient injury.



Warning: Moving parts.

8. Step on the footswitch for two seconds and release the footswitch to initiate a test cutting cycle. Verify that the aperture opens and closes smoothly during the cutting test.

Warning:

If the aperture does not open and close smoothly, remove the biopsy needle and install a new one.

- 9. After the test, the system gives two options: Go to Standby mode or test the Arm and Fire functions of the biopsy needle. (The console returns to Standby mode after the Arm and Fire test is completed.)
- 10. After completion of a successful test cycle, the system is ready for tissue acquisition.

7.4 Prepare for Image Acquisition

Refer to *<u>The Select Patient Screen</u>* on page 44 for detailed information on the screen components.

- 1. Select a patient from the worklist in the *Select Patient* screen, or manually add a new patient (refer to *How to Add a Patient* on page 46).
- 2. In the *Procedure* screen, select the output devices.

- 3. Confirm that the tissue filter drawer is closed and that the system is free of any error messages.
- 4. Turn the Key switch to the unlocked position.

7.5 Attach the Introducer to the Biopsy Device

- 1. With the system in Standby mode, remove the protective sheath from the biopsy needle.
- 2. Carefully slide the introducer over the needle of the biopsy device. Advance the hub of the introducer up to the device driver.




Figure 49: Slide the Introducer onto the Biopsy Device

WARNING!

Make sure to use an aseptic technique when attaching the introducer to prevent contamination.

3. Orient the introducer to select a petite or standard aperture. For an aperture of 20 mm, the 20 mm mark on the introducer lines up with the long mark on the device driver. Rotate the introducer 180° for an aperture of 12 mm, where the 12 mm mark on the introducer lines up with the short mark on the device driver.




Figure 50: Use Standard or Petite Aperture

7.6 Attach a Biopsy Device Adapter to the Biopsy Guidance System

A biopsy device adapter is required to hold the biopsy device in place on a compatible biopsy guidance system. Attach the correct adapter to the biopsy guidance system.

Hologic offers biopsy device adapters for the Brevera breast biopsy system. Refer to the instructions for use provided with the Brevera biopsy needle and with the biopsy device adapter for additional information.




Figure 51: Biopsy Device Adapter

7.6.1 Using the System with Stereotactic (STX) Guidance



Note

Complete training and understanding of your stereotactic guidance system should be provided by the vendor of your stereotactic system.

For additional training or questions on specific stereotactic applications, contact your Hologic Clinical Education Specialist, Hologic Customer Support, or your Hologic distributor.

7.7 Attach the Biopsy Device to the Biopsy Device Adapter

- 1. Place the system in Biopsy mode.
- 2. Press the **Arm** button on the remote control for at least two seconds to arm the biopsy device.
- 3. Align the biopsy device with the biopsy device adapter.
- 4. Slide the biopsy device forward until the introducer on the distal end of the Brevera breast biopsy device engages with the biopsy device adapter and the release latch of the driver engages with the proximal end of the biopsy device adapter. There is an audible click when the pieces are properly engaged, and the biopsy device will no longer slide on the adapter.

7.8 Performing a Biopsy and Acquiring Real-time Images

Perform all steps per standard interventional technique.

- 1. Identify the targeted area and prepare the site as required.
- 2. Assemble the biopsy device and advance it to the desired coordinates provided by the imaging system.



Warning:

If there is a problem advancing the needle into the breast, check the sharpness of the trocar needle tip. Replace the needle if necessary.



Note

X-ray is enabled when the drawer is closed. If the drawer is opened during an exposure, the exposure ends automatically.

- 3. Confirm that the system is ready to perform a biopsy procedure.
 - Confirm that the system is free of any error messages.
 - Confirm that all patient entry steps are complete and that the *Procedure* screen is displayed on the Imaging display.
 - Confirm the aperture size and that the biopsy device is armed.
 - Confirm that the Key switch is in the unlocked position.
 - Confirm that the system is in Biopsy mode.
- 4. Fire the biopsy device by pressing and holding the **Fire** button on the remote control for at least 2 seconds.
- 5. Administer anesthetic (optional).
 - To initiate automatic delivery of anesthetic: Attach a 10 cc needleless syringe of anesthetic to the Y-valve. Inject 1–2 cc of anesthetic via the needleless syringe.
 - To manually administer anesthetic to the area of interest before tissue acquisition: (the biopsy device has been fired, the footswitch has not been depressed) Manually inject anesthetic via syringe and rotate the thumbwheel to allow 360 degrees of access.
 - To manually administer anesthetic to the area of interest during tissue acquisition: (the biopsy device has been fired, the footswitch has been depressed) place the system in Standby mode to close the aperture. Manually inject anesthetic via syringe and rotate the thumbwheel to allow 360 degrees of access. Once complete, return the system to Biopsy mode to continue tissue acquisition.



Note

The device does not allow the Y-valve injection when the device is in the armed (prefire) position.

- 6. Begin tissue acquisition. Press down on the footswitch and hold it in the depressed position throughout the biopsy procedure.
 - Removing your foot from the footswitch will inactivate or stop the device **after** completing the current cycle and the x-ray for the core in that cutting cycle.
 - The system beeps to indicate that it has completed a cutting cycle. A tissue filter icon appears in the thumbnail area to confirm that the cutting cycle is complete and ready for x-ray.
- 7. Acquire a real-time image.
 - The core handling system beeps to indicate that it is taking an x-ray. This beep is significantly softer in volume and tone than the beep that signals the end of the cutting cycle.
 - The Imaging display updates as each x-ray is available. A letter appears to indicate which core sample the image is associated with. The letters A–L in each image indicate the tissue filter chamber.
 - Touch the thumbnail image on the Imaging display to review the image at full size on the Imaging display.
- 8. Rotate the aperture on the outer cannula of the biopsy device by turning the thumbwheel to the next desired position immediately after the system beeps to indicate that it has completed a cutting cycle. The numbers in the window on the biopsy device and the line on the thumbwheel clock dial indicate the position of the aperture.
- 9. Continue tissue and image acquisition until the desired target area has been sampled and imaged. The system beeps two times after twelve cores are taken.
- 10. Review the images and make necessary enhancements. Refer to <u>*How to Review the*</u> <u>*Images*</u> on page 89.

7.8.1 When the Twelve Chambers of the Tissue Filter Contain Cores

The Brevera breast biopsy system with CorLumina imaging technology can acquire more than twelve biopsy cores per tissue filter. For these cases, when each of the twelve chambers in the tissue filter contains a biopsy core, the Brevera breast biopsy system presents two options: to continue using the existing filter or to continue with a new filter.

Continue with the Existing Tissue Filter

- 1. Release the footswitch.
- 2. Press down on the footswitch and hold it in the depressed position throughout the biopsy procedure.
- 3. Continue to acquire biopsy specimens and to view their x-rays on the Imaging display.
- At the end of the tissue acquisition or after the twenty-fourth core specimen, whichever comes first, continue with the instructions for <u>Lavage and Aspirate</u> on page 82.

Continue with a New Tissue Filter

- 1. Release the footswitch.
- 2. Open the tissue filter drawer.
- 3. Remove the tissue filter cover from the tissue filter assembly.
- 4. Place a dry tissue filter cap on the tissue filter. (The tissue filter cap is provided with the biopsy needle.)
- 5. Remove the used filter from the tissue filter assembly and the tissue filter drawer.
- 6. Place the used tissue filter in a specimen jar on the surface of the formalin.

Note

The specimen jar should have a minimum inner diameter of 6.1 cm (2.4 inches) and a minimum height of 5.7 cm (2.25 inches) in order to fit a Brevera tissue filter.

- 7. Slowly submerge the tissue filter to allow the formalin to enter the chambers and air to escape. (Do not allow the tissue filter to float on top of the formalin.) Prepare the specimens for pathology per facility policy.
- 8. Install a new tissue filter.
- 9. Replace the cover on the tissue filter assembly, and close the tissue filter drawer. The system is ready when the indicators on the Imaging display return to green.
- 10. Select **Yes** on the Imaging display when asked if a new filter was inserted into the drawer.
- 11. Depress the footswitch.
- 12. Continue to acquire biopsy specimens and to view their x-rays on the Imaging display.
- 13. At the end of tissue acquisition or after the twenty-fourth core specimen, whichever comes first, continue with the instructions for *Lavage and Aspirate* on page 82.

7.8.2 Lavage and Aspirate

Lavage

Select Lavage mode to irrigate the cavity and to clear the biopsy device of tissue. The system will turn the vacuum on, open the aperture, open the saline pinch valve, and close the aspiration valve in order to push saline through the aperture. It is not necessary to depress the footswitch.

Aspirate

Select Aspirate mode to vacuum the cavity. The system will turn the vacuum on, open the aperture, close the saline pinch valve, and open the aspiration valve in order to push air through the aperture. It is not necessary to depress the footswitch.

7.8.3 Conclude Tissue Acquisition

- 1. Release the footswitch. Select Standby mode to close the aperture prior to removal of the biopsy device from the biopsy cavity.
- 2. Remove the biopsy needle and device driver as a unit from the biopsy device adapter while leaving the introducer in place for marker deployment. (Use the release latch on the back of the device driver to detach the biopsy device from the adapter.)
- 3. After removing needle from the breast, use the aspirate mode to clear the needle aperture.
- 4. Press the buttons on the sides of the biopsy needle to disengage it from the device driver. Detach the biopsy needle from the device driver and discard in a sharps container. (The tubing and tissue filter are removed from the console later.)



Warning:

Do not place fingers on the metal parts of the device driver. These parts can move during system use.

Note

The console beeps three times before resetting the position of the metal parts of the device driver.

5. Slide the device driver onto the device driver holder on the console until it clicks.

7.8.4 Deploying a Biopsy Site Marker

To deploy a biopsy site marker, refer to the biopsy site marker instructions for use.



Note

Make sure that the correct biopsy marker is selected for the needle length used.

After deploying an optional biopsy site marker, retract the introducer and stereotactic adapter from the patient (refer to <u>*Remove the Biopsy Device Adapter*</u> on page 83).

7.8.5 Remove the Biopsy Device Adapter

- 1. After deploying an optional biopsy site marker, pull back the introducer and the biopsy site marker deployment device from the breast as one unit by moving the biopsy device adapter away from the patient.
- 2. After everything is retracted from the patient, remove the introducer and biopsy site marker deployment device as a unit from the biopsy device adapter by pinching the wing tabs on the introducer. Slide the introducer back from the adapter. Dispose of the introducer and marker deployment device per facility policy.
- 3. Refer to the instructions for use provided with the biopsy device adapter for additional information regarding removal of the adapter from the biopsy guidance system.
- 4. Immediately following the procedure, properly clean and disinfect the biopsy device adapter as recommended in the section <u>Maintenance, Cleaning, and Disinfecting</u> on page 99.



Note

Complete training and understanding of your biopsy guidance system should be provided by your biopsy guidance system vendor.

7.9 Conclude the Procedure

- 1. Confirm that the console is in Standby mode.
- 2. Open the tissue filter drawer.
- 3. Remove the tissue filter cover from the tissue filter assembly.
- 4. Place a dry tissue filter cap on the tissue filter. (The tissue filter cap is provided with the biopsy needle.)
- 5. Remove the used filter from the tissue filter assembly and the tissue filter drawer.
- 6. Place the used tissue filter in a specimen jar on the surface of the formalin.



Note

The specimen jar should have a minimum inner diameter of 6.1 cm (2.4 inches) and a minimum height of 5.7 cm (2.25 inches) in order to fit a Brevera tissue filter.

- 7. Slowly submerge the tissue filter to allow the formalin to enter the chambers and air to escape. (Do not allow the tissue filter to float on top of the formalin.) Prepare the specimens for pathology per facility policy.
- 8. Replace the cover on the tissue filter assembly.
- 9. Release the tissue filter assembly from the locator pins and temporarily leave in the drawer.
- 10. Remove the suction tubing from the tubing guides on the two sides of the drawer.
- 11. Remove the suction tubing from the suction canister.
- 12. Remove the saline tubing from the saline pinch valve. Remove the spike from the saline bag.
- 13. Gather all the tubing and the tissue filter assembly and discard in the sharps container with the previously discarded biopsy needle.
- 14. Dispose of the saline bag per facility policy.
- 15. Dispose the needle guide per facility policy.
- 16. Close the tissue filter drawer.
- 17. Disconnect the vacuum line assembly from the suction canister, and close the suction canister ports. Dispose of the suction canister per facility policy for biohazardous waste.
- After log out and shut down, perform the recommended cleaning and disinfection procedures. Refer to the section <u>Maintenance, Cleaning, and Disinfecting</u> on page 99 for more information.

7.10 How to Change the Biopsy Needle Between Procedures

Follow these instructions to change the biopsy needle for a new procedure.

- 1. Confirm that the console is in Standby mode.
- 2. Press the buttons on the sides of the biopsy needle to disengage it from the device driver. Detach the needle from the driver and place it in a sharps container.



Warning: Do not place fingers on the metal parts of the device driver. These parts can move before a biopsy needle is installed.



Note

The console beeps three times before resetting the position of the metal parts of the device driver.

- 3. Slide the device driver onto the device driver holder on the console until it clicks.
- 4. Wait for the device driver to automatically home in preparation for a new biopsy needle.
- 5. Follow the instructions in *<u>Conclude the Procedure</u>* on page 84 to disconnect and remove the biopsy supplies.
- 6. Install the new biopsy supplies and the new biopsy needle. Refer to <u>Connect the</u> <u>Device Driver and the Biopsy Supplies</u> on page 69 for detailed instructions.




Figure 52: System Recognizes When the Device Driver Is Ready




Figure 54: System Recognizes When the Device Driver Is Ready

Chapter 8 The Images

8.1 Introduction

After you make an exposure, the acquired image displays and is accepted automatically. A thumbnail image appears on the screen, with the corresponding letter designation for the tissue filter chamber. Use the image functions to tag, review, enhance, and annotate the images or reimage the cores.

8.2 How to Review the Images

Select a thumbnail image.

- A preview image shows in the large window on the screen.
- Use the image tools (refer to <u>Image Enhancement Tools</u> on page 92) to enhance the whole image or areas of interest in the image.

8.2.1 How to Tag an Image

The Tag tool is the round button in the upper right corner of the image. Pressing this button selects or deselects the active image. Tagged images show a green check mark in the upper right of the image and the image thumbnail. The check mark is burned into the tagged images that are exported, archived, or printed.

8.2.2 The Review Mode Screen

The *Review Mode* screen allows for a quick review of the images. The *Review Mode* screen no longer shows an active image and instead shows larger thumbnails of the images. The images can be quickly tagged by selecting them from the group of images instead of tagging them individually from the *Procedure* screen. The *Review Mode* screen includes a Tag All and a Clear All feature.




Figure 58: Review Mode Screen

8.2.3 Image Enhancement Tools

When you select the **Tools** button, the Image Enhancement Tools bar displays on the active image. Select the tool icon to enable it. The active tool appears to be pressed into the tools bar.




Figure 59: Image Enhancement Tools

Figure Legend

- 1. The Pan tool is used to move the view to a different portion of the image by dragging.
- 2. The Zoom tool magnifies the whole image. Drag up to zoom in and make the image larger. Drag down to zoom out and make the image look smaller.
- 3. The Circle tool is used to draw a circle on the image. Drag up or down to make the circle larger or smaller. Once the circle is placed its size cannot be changed, but it can be moved by dragging or deleted by double-tapping.
- 4. The Window/Level tool is used to change the brightness and contrast.
- 5. The Enhanced Visualization tool adjusts the image sharpness.
- 6. The Invert tool changes blacks to white and whites to black.
- 7. The Reset tool returns an image to the original state. Any annotations, panning, zooming, etc. are removed.
- 8. The Tag tool selects a particular image or images. Tagged images show a green check mark in the upper right of the thumbnail image. The check mark is burned into the tagged images that are exported, archived, or printed off the system.
- 9. The Enhancement Level is displayed when the Enhanced Visualization tool is active. The level of enhancement can be adjusted from greater (5) to lesser (1) in real time.
- 10. The **Delete** button deletes a snapshot.
- 11. The **Camera** button captures a snapshot of the image display area and adds the snapshot to the current procedure.

Note

The Enhanced Visualization tool is inactive for snapshot images.

8.2.4 The Filter Info and Comments Screen

From the *Procedure* screen, click on the **Filter Info** button to make notes or comments about image content. One set of comments can be added per tissue filter. Comments are saved with the images from that tissue filter and are exported with the image or images.




Figure 60: Filter Info and Comments Screens

Figure Legend

- 1. Scroll between the two screens using the arrows.
- 2. Use the on-screen keyboard to type, edit, and remove Filter Comments.
- 3. The Procedure Info is the information already in the system for the procedure. It cannot be edited on the *Filter Info and Comments* screen.
- 4. Select the Save button to save the Filter Info and Comments.
- 5. Indicate the quadrant for the specimens in that particular tissue filter.
- 6. Select the **Back** button to exit the *Filter Info and Comments* screen without saving and return to the previous screen. If there are unsaved changes, a prompt displays the option to save or continue without saving the comments.
- 7. Enter, edit, and remove additional Filter Comments using the on-screen keyboard.
- 8. Select from a predefined list describing the specimens in that particular tissue filter.
- 9. Use these circles to scroll between the two screens. A red exclamation point in a circle indicates that there is an error that needs to be fixed on that screen.

8.2.5 How to Reimage

Select the **Reimage** button to acquire a new image of the core shown in the active image.

8.3 Send the Images to the Output Devices

You can send the images to output devices or use the Export function to copy images to a temporary storage device. Refer to <u>*How to Use the Output Set*</u> on page 53 for instructions.

Chapter 9 System Administration Interface

9.1 The Admin Screen

This section describes the functions available in the *Admin* screen. To access this screen:

- 1. Log in to the system.




Figure 61: Admin Screen




Figure 62: System Tools Button

Chapter 10 Maintenance, Cleaning, and Disinfecting



Warning:

Do not perform maintenance, cleaning procedures, or disinfection while the system is being used on a patient.

10.1 General Information

10.1.1 For General Cleaning

This procedure includes cleaning the unit and the surfaces that the specimens do not contact.

Use a lint-free cloth and apply a diluted, mild detergent to clean components and surfaces. To remove more difficult soils, use a soft bristle brush as needed.



Caution: Use the least possible amount of cleaning fluids. The fluids must not flow or run.

10.1.2 For Disinfecting

To disinfect the system's components and surfaces, Hologic recommends the following disinfecting solutions:

- 10% chlorine bleach and water with one part commercially available chlorine bleach (normally 5.25% chlorine and 94.75% water) and nine parts water. Mix this solution daily for best results.
- Commercially available isopropyl alcohol solution (70% isopropyl alcohol by volume, not diluted)
- Commercially available wipes containing less than or equal to 2% quaternary ammonium compounds by weight in water.

Apply disinfecting solutions to the system using a clean, lint-free cloth or wipe. Wipe the system with the wet cloth, observing appropriate contact (wet) times. Do not spray cleaning solutions directly on the console or other parts of the Brevera breast biopsy system.



Caution:

To prevent damage to the electronic components, do not use disinfectant sprays on the system.

10.1.3 To Prevent Possible Injury or Equipment Damage

Do not use a corrosive solvent, abrasive detergent, or polish. Select a cleaning/disinfecting agent that does not damage the plastics, aluminum, or carbon fiber.

Do not use strong detergents, abrasive cleaners, high alcohol concentration, or methanol at any concentration.

Do not expose equipment parts to steam or high temperature sterilization.

Do not let liquids enter the internal parts of the equipment. Do not directly apply cleaning sprays or liquids to the equipment. Always use a clean, lint-free cloth and apply the spray or liquid to the cloth. If liquid enters the system, disconnect the electrical supply and examine the system before returning it to use.



Caution:

Wrong cleaning methods can damage the equipment, decrease imaging performance, or increase the risk of electrical shock.

Always follow instructions from the manufacturer of the product you use for cleaning and disinfection. The instructions include the directions and precautions for the application and contact time, storage, wash requirements, protective clothing, shelf life, and disposal. Follow the instructions and use the product in the most safe and effective method.

10.2 Component Specific Cleaning and Disinfection



WARNING!

The console must be disconnected from electrical power source prior to cleaning. Failure to do so may cause electrical shock or death.

WARNING!

Do not immerse the console in water. Immersion in water will cause damage and may cause electrical shock or death.

10.2.1 How to Clean and Disinfect the Console Exterior Surfaces

- Disconnect the console from the electrical power source.
- After each use, clean the console using a soft, damp cloth and mild detergent. Wipe dry.
- After cleaning, use a pre-moistened disinfectant wipe or apply a disinfectant solution to a clean cloth. Wipe all surfaces with the wipe or wet cloth, observing appropriate contact (wet) times. Refer to <u>General Information</u> on page 99 for recommended disinfecting solutions.
- Do not spray cleaning or disinfectant solutions directly on the console or other parts of the Brevera breast biopsy system.

10.2.2 How to Clean and Disinfect the Device Driver and Remote Control

- Disconnect the console from the electrical power source.
- After each use, clean the reusable device driver using a soft, damp cloth and mild detergent. Wipe dry.
- After cleaning, use a pre-moistened disinfectant wipe or apply a disinfectant solution to a clean cloth. Wipe all surfaces with the wipe or wet cloth, observing appropriate contact (wet) times. Refer to <u>*General Information*</u> on page 99 for recommended disinfecting solutions.
- Do not spray cleaning or disinfectant solutions directly on the reusable device driver, the remote control, or other parts of the Brevera breast biopsy system.
- Do not immerse the reusable device driver in liquid.

10.2.3 How to Clean and Disinfect the Tissue Filter Drawer

- Disconnect the console from the electrical power source.
- After each use, clean the tissue filter drawer using a soft, damp cloth and mild detergent. Wipe dry.
- After cleaning, use a pre-moistened disinfectant wipe or apply a disinfectant solution to a clean cloth. Wipe all surfaces with the wipe or wet cloth, observing appropriate contact (wet) times. Refer to <u>*General Information*</u> on page 99 for recommended disinfecting solutions.
- Do not spray cleaning or disinfectant solutions directly in the drawer or other parts of the Brevera breast biopsy system.

10.2.4 How to Clean the Imaging Display

- Disconnect the console from the electrical power source.
- Use care when you clean the outer surface of the display area.
- Always use a clean, soft, lint-free cloth to clean the display area. Microfiber cloths, available at most stores, are recommended.
- Use a pre-moistened disinfectant wipe or apply disinfectant solution to a clean cloth. Wipe all surfaces with the pre-moistened wipe or wet cloth, observing appropriate contact (wet) times. Refer to <u>General Information</u> on page 99 for recommended disinfecting solutions.
- Strong chemicals and abrasives can damage the display window and should never be used.
- Never apply pressure to the display window.
- Never use a spray or flow a liquid onto the display.
- Never use steel wool.
- Never use a sponge with abrasives.

Note



There are many commercially available products to clean LCD displays. Any product that is free of the ingredients or abrasives described above and used according to the directions of the manufacturer can be safely used.



Note There are commercially available disposable monitor drape products to drape LCD touch screen displays. Always follow instructions from the manufacturer of the product you use.

10.2.5 How to Clean the Technologist Display

- Disconnect the console from the electrical power source.
- Do not touch the display when working with specimens.
- Use care when you clean the outer surface of the display area.
- Always use a clean, soft, lint-free cloth to clean the display area. Microfiber cloths, available at most stores, are recommended.
- To clean the button area of the technologist display, use a pre-moistened disinfectant wipe or apply a disinfectant solution to a clean cloth. Wipe all surfaces with the pre-moistened wipe or wet cloth, observing appropriate contact (wet) times. Refer to <u>General Information</u> on page 99 for recommended disinfecting solutions.
- Strong chemicals and abrasives can damage the display window and should never be used.
- Never apply pressure to the display window.
- Never use a detergent with fluorides, ammonia, alcohol, bleach, or abrasives to clean the display window.
- Never use a spray or flow a liquid onto the display.
- Never use steel wool.
- Never use a sponge with abrasives.

Note

There are many commercially available products to clean LCD displays. Any product that is free of the ingredients or abrasives described above and used according to the directions of the manufacturer can be safely used.

10.2.6 How to Clean the Footswitch

WARNING!

Do not immerse the footswitch in water. Immersion in water will cause damage and may cause electrical shock or death.

- 1. Disconnect the footswitch from the console.
- 2. Periodically clean the footswitch using a soft, damp cloth and mild detergent.
- 3. Wipe the footswitch dry.

10.3 Preventive Maintenance

Every twelve months, the preventive maintenance service is to be performed only by Hologic Technical Services or a Hologic-certified technician.

Contact Hologic Technical Support or your local Hologic representative for more information on preventive maintenance and biomedical training.

10.3.1 Vacuum Line Assembly

How to Inspect the Vacuum Line Assembly

- 1. Once a week, visually inspect the tubing for any fluid or moisture.
- 2. Visually inspect the white side of the in-line hydrophobic filter for any discoloration.
- 3. If the tubing is wet or the filter is discolored, replace the vacuum line assembly.

How to Replace the Vacuum Line Assembly

- 1. Power off the system.
- 2. Locate the white lock collar where the vacuum line assembly attaches to the console.
- 3. Lift up the vacuum line assembly approximately 3 mm (1/8 inch) to expose a gap between the white collar and the base of the black barb.
- 4. Hold down the white collar and pull the vacuum line assembly up and out of the connector. Discard as biohazardous waste.
- 5. Press a new vacuum line assembly into the vacuum line assembly connector.
- 6. Pull up to check that the new vacuum line assembly is locked into the connector. The vacuum line assembly will have a small amount of vertical movement but should not pull free of the connector.



Note

Do not twist the vacuum line assembly as you pull up.

- 7. Power on the system.
- 8. Plug the vacuum inlet line using your thumb or finger.
- 9. Press the **Test** button on the console.
- 10. Check that the system displays an indicator that the vacuum system is functioning correctly.
- 11. Power off the system if desired.

10.3.2 Device Driver

How to Inspect the Device Driver

- 1. Once a week, visually inspect the cable and connectors. The cable should not be cracked or damaged.
- 2. Once a week, visually inspect the area where the biopsy needle connects with the device driver.
- 3. If the device driver or its cable appears worn or damaged, replace the device driver.

How to Replace the Device Driver

- 1. Power off the system.
- 2. Completely unwrap the device driver cord and remove it from the cord management plate.
- 3. Unplug the device driver from the console.
- 4. Using a new device driver, insert the cord into the receptacle. (The red dots align at the top when attached correctly.)
- 5. Wrap the cord around the cord management plate.
- 6. Power on the system. The console beeps, and the *Setup* screen appears on the Technologist display.
- 7. Install a suction canister, biopsy needle, saline, and tissue filter assembly as if performing a biopsy.
- 8. Check that the system displays an indicator that the device driver, biopsy needle, and tissue filter are connected and installed. Complete the Setup check list as prompted.
- 9. When the system is ready for Test mode, the green **Test** button will flash. Press the **Test** button to begin the testing procedure.
- 10. Follow the prompts on the Technologist display until testing is complete.
- 11. When testing is successful, the system goes into Standby mode.
- 12. Power off the system if desired.
- 13. Contact your local Hologic representative for product return instructions.

10.3.3 Footswitch

How to Inspect the Footswitch Cord

- 1. Once a week, visually inspect the cord and connector. The cord should not be cracked or damaged.
- 2. Verify that the footswitch cord is wrapped counter-clockwise (CCW) direction around the cord management plate.
- 3. If the footswitch or its cord appears worn or damaged, replace the footswitch.

How to Replace the Footswitch

- 1. Power off the system.
- 2. Completely unwrap the footswitch cord and remove it from the cord management plate.
- 3. Unplug the footswitch cord from the console.
- 4. Using a new footswitch, plug the cord into the console.
- 5. Wrap the footswitch cord counter-clockwise around the cord management plate.
- 6. Power on the system. The console beeps, and the *Setup* screen appears on the Technologist display. Install a suction canister, biopsy needle, saline, and tissue filter assembly as if performing a biopsy.
- 7. Check that the system displays an indicator that the device driver, biopsy needle, and tissue filter are connected and installed. Complete the Setup check list as prompted.
- 8. When the system is ready for Test mode, the green **Test** button will flash. Press the **Test** button to begin the testing procedure.
- 9. Follow the prompts on the Technologist display until testing is complete.
- 10. When testing is successful, the system goes into Standby mode.
- 11. Power off the system if desired.
- 12. Contact your local Hologic representative for product return instructions.

10.3.4 Power Cord

How to Inspect the Power Cord

- 1. Once every quarter, visually inspect the power cord for cuts, damage to the cover, or strain relief.
- 2. If the power cord appears damaged, contact Hologic for replacement of the power cord.



Appendix B Troubleshooting

B.1 Error Recovery and Troubleshooting

Most faults and alert messages are cleared without result to your workflow. Follow the instructions on the screen or fix the condition then clear the status from the Taskbar. Some conditions require a system restart or indicate that more action is necessary (for example, to call Hologic Technical Support). This appendix describes the message categories and your actions to return the system to normal operation. If errors repeat, contact Hologic Technical Support.

B.2 Types of Messages and Alert Messages

B.2.1 Fault Levels

There are five fault levels: Warning, Minor, Major, Critical, and Alerts.

Warning Faults

The Warning faults are not displayed to the user. These faults are recorded in the log files.

Warning fault designs:

- Resolve through the software or communications commands.
- Do not cancel an exposure that is in progress.
- Do not prevent the start of a new exposure.

Minor Faults

Minor fault designs:

- Resolve through the software or communications commands.
- Do not cancel an exposure that is in progress.
- Require a response before a new exposure can start.

Major Faults

Major fault designs:

- Resolve through the software or communications commands.
- Cancel an exposure that is in progress.
- Prevent the start of a new exposure.

Critical Faults

Critical fault designs:

- Not resolved through the software or communications commands.
- Cancel an exposure that is in progress.
- Prevent the start of a new exposure.

Alert Messages

The Alert Messages are routine messages that can prevent an exposure. An Alert message remains active until the required action is complete or the condition no longer exists.

B.2.2 System Messages

Select the system status icon on the Taskbar to get information about the cause and correction of a system problem. When you correct the problem, the System Message area displays a Ready status.

B.3 System Restart

- To restart the computer system after a critical fault, select the **Reboot** button.
- If you select the **Exit** button, a message advises that this option shuts down only the computer.
