# **Warnings and Precautions**

- A. Avoid contact of Auto Detect 2 with skin, eyes, and mucous membranes. If this fluid comes into contact with skin or eyes, wash with water. If this fluid spills, dilute the spill with water before wiping dry.
- B. Use routine laboratory precautions.

# Storage and Handling Requirements

- A. Store the Aptima Auto Detect Kit at 15°C to 30°C.
- B. Fluids must be at 15°C to 30°C before use. Once opened, fluids are stable for 60 days.
- C. If precipitate has formed, heat the fluids at 37°C to 60°C to facilitate dissolution of the precipitate. Cool the fluids to room temperature and thoroughly mix prior to use.
- D. Do not use after the expiration date.
- E. Some reagents of this kit are labeled with risk and safety symbols.
